XTREMECRAZE ACKNOWLEDGEMENT AND RELEASE

For and in consideration of the admission price and the permission to use the XTREMECRAZE Facilities you hereby agree and acknowledge the following on behalf of yourself and/or your children or the children under your care.

- 1. That you are only authorized to use the XTREMECRAZE premises and facilities upon the proper execution of this document.**
- 2. That this document is a material part of the consideration and agreement between you and XTREMECRAZE for the admission to and use of its premises and facilities.**
- 3. If you are permitted to use the airpark, lasertag, or other facilities, that you agree, and you agree to cause the children in your care, to follow all rules posted throughout the facility and that SAFETY IS YOUR RESPONSIBILITY.**
- 4. That you have read this entire document and completely understand its contents. You also acknowledge that you have read and understood and agree to be bound by its terms. I understand that employees working at XtremeCraze, including the manager, do not have the authority to waive any provision of this Agreement. This Agreement constitutes and contains the entire agreement between XtremeCraze and you relating to the Child's and my use of the XtremeCraze Facility.**
- 5. You acknowledge that the owners and operators of XTREMECRAZE have employed diligent efforts and care in making the facilities and premises as safe as possible; and that despite the foregoing efforts, you understand that there are, nevertheless, certain inherent risks in using the facilities and premises. That if you or your property are injured while using the premises and facilities as a result of the inherent risks and dangers mentioned above, you agree to RELEASE from Liability, INDEMNIFY, AND HOLD HARMLESS Hughes entertainment, Inc., and Good Fun LLC. dba XTREMECRAZE, its employees, assigns, and affiliated entities FROM SAID INJURIES OR ANY COSTS OR EXPENSES ASSOCIATED THEREWITH.**
